

FROM THE SOUTH (I-93 NORTHBOUND)

Take Exit 23 off I-93 (Gov't Center/North End/Aquarium/Quincy Market). Follow the sign to Aquarium, to the left. This loops around and puts you on Surface Rd. After three blocks, make a left on Milk St. and head straight to the Aquarium.

OR

Take exit 20 (South Station). The exit ramp puts you onto Atlantic Ave. Stay on Atlantic for 5 blocks, make a right on Milk St. and head straight to the Aquarium.

FROM THE NORTH (I-93 SOUTHBOUND)

Take Exit 24A (Government Center) and stay left. At the traffic light, turn onto Atlantic Ave. Follow Atlantic Ave. for 3 lights, then make a left on Milk St. The Aquarium is straight ahead.

FROM THE WEST (I-90 EAST to I-93 NORTHBOUND)

Take the Mass Turnpike East to I-93 North. Take Exit 23 off I-93 (Gov't Center/North End/Aquarium/Quincy Market) Follow the sign to Aquarium, to the left. This loops around and puts you on Surface Rd. After three blocks, make a left on Milk St. and head straight to the Aquarium.

DROP-OFF/PICK-UP

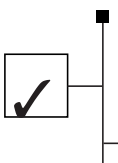
Use the designated bus turnaround for drop-off and pick-up. There is a 10-minute window for drop-off and pick-up. Please coordinate with your bus driver.

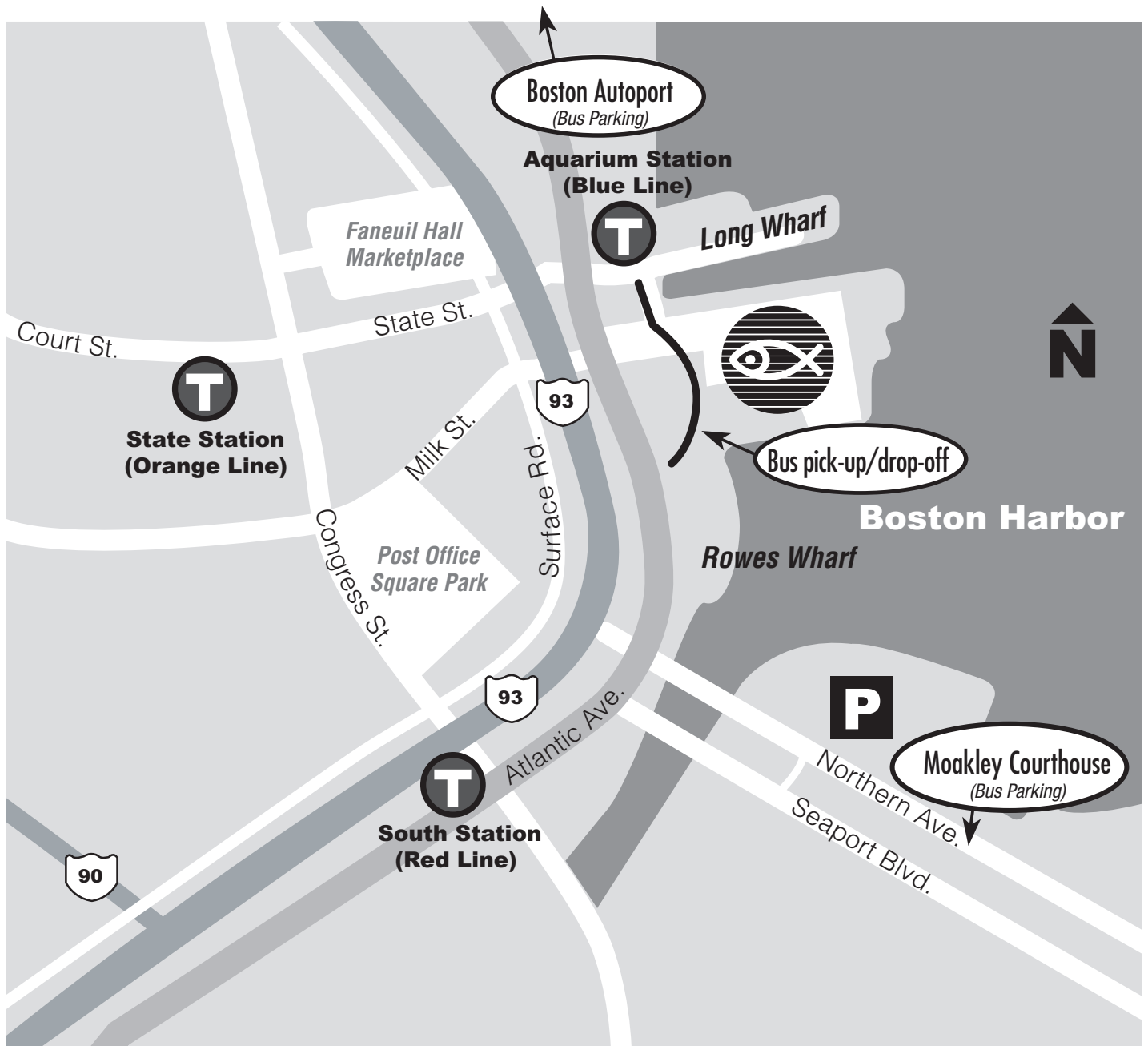
BUS PARKING

While the Aquarium itself does not have bus parking facilities, we do have some recommendations:

Boston Autoport: Travel to State St. to the first traffic light. Turn right onto Atlantic Ave. Proceed north on Atlantic to set of lights at intersection with Causeway St. and North Washington St., approximately 1 mile. At intersection, turn right onto North Washington St. (You will drive over a small expansion bridge). At first set of lights (City Square) turn right onto Chelsea St. Follow Chelsea to the end, which positions you under the Tobin Bridge. Once under the bridge, you will travel over a small water channel. Once over the channel you will see signs for **Bus Parking** on wood fence. Turn right into Mystic Pier 1 property and proceed to Station 1. Wait for attendant to sign in. Please call **617-886-9300** for current parking fees.

Moakley Courthouse: Travel North on Atlantic Ave. Take a left onto State St. Turn left onto Surface Rd., which then becomes Purchase St. Turn left onto Seaport Blvd., and then left onto Sleeper St. Turn right onto Northern Ave., and then left onto Courthouse Way. Parking at the Courthouse is currently \$9 per day; prices are subject to change.
